CONDITIONS OF THIS PERMIT

This permit is granted subject to the following conditions. Failure to comply with any of the terms and conditions of this permit may result in the immediate suspension or revocation of the permit. [36 CFR 1.6(h)]

1. The permittee is prohibited from giving false information; to do so will be considered a breach of conditions and be grounds for revocation: [36 CFR 2.32(a)(3)].
2. This permit may not be transferred or assigned.
3. Except for the fenced area described on page 1 of this permit, this permit does not guarantee exclusive use of any area within the Golden Gate National Recreation Area.
4. The National Park Service reserves the right to immediately revoke this permit at any time should it reasonably appear that the public gathering presents a clear and present danger to the public safety, good order or health, or if any conditions of this permit are violated. NPS retains the right to change the permitted event venue or route, or cancel this permit based on security or weather-related concerns. This potential cancellation may occur at any time.
5. This permit is made upon the express condition that the United States, its agents and employees shall be free from all liabilities and claims for damages and/or suits for or by reason of any injuries or death to any person or property of any kind, including to the person or property of the Permittee, its agents or invitees, and to third parties, from any cause or causes whatsoever while in or upon said premises or any part thereof during the term of this permit or occasioned by any occupancy or use of the premises by the Permittee, its agents and invitees. The Permittee agrees to save and hold harmless the United States of America, and its agents and employees, for and from any and all claims, demands, damages, and suits at law or equity, of whatever kind or nature, for damages to or loss of property, or injury or death to persons resulting directly or indirectly from, or attributable to the Permittee, its agents or invitees in conjunction with activities authorized by this permit.
6. If any provision of this permit shall be found to be invalid or unenforceable, the remainder of this permit shall not be affected and the other provisions of this permit shall be valid and be enforced to the fullest extent permitted by law.
7. All laws, rules, and regulations applicable to the area covered by this permit that are not inconsistent with the terms of this permit remain in effect.

PERMIT CONDITIONS CONTINUED: PARK SPECIFIC CONDITIONS

8. Failure to abide by all applicable laws, regulations, and permit conditions and all reasonable directions given by law enforcement personnel may result in individuals associated with the above permitted event being subject to citation and/or revocation of this permit.
9. The Permittee must designate an onsite point of contact (also known as the Event Manager) who will be available and responsive to any questions or issues during the day to the National Park Service and law enforcement staff working the event. The Event Manager is responsible for ensuring that the activities of permittee, its agents and invitees are in compliance with the terms of this permit and all reasonable directions and orders of law enforcement personnel. Permittee has advised the NPS that it may invite individuals not affiliated with permittee's organization into the permitted area. **The Event Manager will be the one to determine which individuals are allowed into the fenced area described on page 1 of this permit. Permittee assumes all risk and responsibility associated with inviting such individuals into the permitted area.**

This permit must be carried by the Event Manager at all times during the event, and the Event Manager **must** be on-site at all times during the event.

10. Permittee may designate Event Monitors for the event who will assist with managing the activities of Permittee's members and invitees. If Permittee chooses to designate Event Monitors, permittee shall provide the names of such individuals to law enforcement staff on the day of the event and provide armbands, vests or hats that will clearly identify each Event Monitor. Event Monitors are not authorized to act in a law enforcement capacity for the event and shall follow all reasonable directions and orders of law enforcement staff. Permittee is not authorized to bring or use private security personnel for this event.
11. Per FAA regulations, use of drones, quadcopters or any unmanned aircraft or contrivance used or designed to navigate or fly in the air is prohibited. Use of unmanned aircraft is not permitted for the above event and is subject to citation under 36 CFR 1.5 (a) (1)
12. Permittee may not interfere with pedestrian or vehicular traffic or block entrances, sidewalks, trails or driveways.
13. The National Park Service will contact permittee by phone 24 hours before the set-up time for the event to advise permittee where members of Patriot Prayer can park their vehicles. Before and after the event, permittee and members of Patriot Prayer will be

escorted between the designated parking area and the permitted 1st Amendment area on Crissy Field by law enforcement personnel. The National Park Service does not assume responsibility for parked vehicles or their contents.

14. No food service has been approved for this activity. Permittee may not sell food or beverages.
15. Camping is prohibited. Per 36 CFR 1.4 (a), camping means the erecting of a tent or shelter of natural or synthetic material, preparing a sleeping bag or other bedding material for use, parking of a motor vehicle, motor home or trailer, or mooring of a vessel for the apparent purpose of overnight occupancy.
16. Commercial notices or advertisements shall not be displayed, posted or distributed on park property. Permittee may distribute printed matter and electronic media free of charge provided that such materials are limited to message-bearing textual printed material such as books, pamphlets, magazines and leaflets, or message-bearing electronic media, whose primary purpose is the advocacy, definition or explanation of a group's or individual's political, religious, scientific or moral beliefs. All other forms of merchandise, including posters, coffee mugs, T-shirts, hats and other clothing materials may not be sold in the park during the term of this permit.
17. Permittee is not authorized to access NPS utilities at any time during the term of this permit.
18. One whisper quiet generator is permitted. Such generator must be on level pavement or plywood, with a nearby, clearly visible fire extinguisher (within 20'). No refueling is permitted on-site.
19. Permittee is authorized to use speakers for sound amplification. Such speakers must face away from residences, businesses or sensitive habitat areas (e.g. Crissy Field marsh, snowy plover habitat). Amplified sound cannot exceed levels that would reasonably disturb people who are not participating in the event.
20. Permittee may erect a stage not exceeding 8' x 12' x 2' within the permitted area, provided that load-in and set up is done in accordance with permit conditions and NPS staff directions. The stage may not be more than 24" high. Permittee must provide plywood or other means for the feet of the stage to not sink in to the grass. The ground is not level. The stage does not need to be ADA compliant. Permittee is not authorized to bring chairs, tables, lecterns or similar items onto the stage.

All cables must be covered with 'yellow jackets' or other ADA compliant cable covers.

NPS is not responsible for any equipment, items, infrastructure, etc. left on site by permittee. Unattended equipment may be considered abandoned property.
The permittee shall ensure that all approved equipment related to this event that is placed on park property adheres to all applicable codes, standards, and regulations including, but not limited to, BOCA, OSHA, USPHS, and ADA.
21. Permittee may not make any alterations to the site, including any digging or placement of equipment, such as stakes, below the ground surface. Permittee will conduct the event with utmost care and ensure that no natural, historic, or cultural features are injured. After completion of the permitted demonstration, the permitted area will, as required by the NPS official(s) in charge, either be cleaned up and restored to its prior condition, or cleaned up to meet the conditions satisfactory to the NPS official(s) in charge.
22. The use, location and placement of all equipment is at the discretion of law enforcement personnel and subject to relocating or removal for resource protection, safety concerns, etc.
23. If the permittee decides to cancel the demonstration, permittee shall advise Golden Gate National Recreation Area as soon as possible.
24. Participants must avoid any communications, written, printed, or spoken, which imply any connection, either official or unofficial, with the National Park Service and its activities.
25. Permittee may not enter areas closed to the public as noted by signs, fencing, or regulations without NPS permission in advance and NPS supervision. Permittee may not set-up, load-in, unload or in any other way begin the event without the Event Manager first meeting with NPS staff prior to the time at which this permit begins (11 a.m.) .
26. Law enforcement personnel may enter any permitted area at any time and for any reason.
27. The items listed on Attachment A are prohibited and may not be brought into the Secured Area that will be designated by the National Park Service for this event. All persons entering the Secured Area will be screened for prohibited items. The Secured Area is generally depicted on Attachment B and will be designated by signs and secured entrance points on the day of the event. The permitted area is within the Secured Area and therefore such items may not be brought into the permitted area either.

Secured Area List of Prohibited Items
Saturday August 26, 2017**

The following items are prohibited within the Secured Area that is being established for this event:

- A. Aerosols / pressurized canisters
- B. Ammunition
- C. Animals other than working service animals
- D. Any other items determined to be potential safety hazards
- E. Backpacks and bags exceeding the size restriction of 18" by 14" by 7"
- F. Balloons
- G. BBQ grills (propane tanks with any open flame)
- H. Bicycles
- I. Coolers
- J. Drones and other unmanned aircraft systems
- K. Explosives
- L. Firearms (including licensed concealed carry firearms)
- M. Gas Masks
- N. Glass, thermal or metal containers
- O. Helmets
- P. Laser pointers
- Q. Liquids (other than water in factory-sealed, clear plastic bottles)
- R. Mace / pepper spray
- S. Packages
- T. Pop up tents or canopies
- U. Selfie sticks
- V. Shields
- W. Signs exceeding the size restriction of 24" by 36" (Signs will only be allowed if made of foam core, cardboard or paper)
- X. Structures
- Y. Supports for signs and placards including sticks of any material
- Z. Sticks or bats of any nature composed of any material
- AA. Toy or replica guns
- BB. Wagons or carts that can be pulled
- CC. Weapons of any kind
