**Additional Information:** The National Park Service has terms and conditions on all commercial service agreements. The following terms and conditions will apply to all Commercial Use Authorizations. There may be additional terms and conditions based on the

services provided. These may include but are not limited to limits on locations, times, group size, and employee licenses and certifications and providing such information to the park superintendent for approval.

#### **CONDITIONS OF THIS AUTHORIZATION**

- 1. False Information: The holder is prohibited from knowingly giving false information. To do so will be considered a breach of conditions and be grounds for revocation: [RE: 36 CFR 2.32(a) (3)].
- 2. Legal Compliance: The holder shall exercise this privilege subject to the supervision of the area Superintendent. The holder shall comply with all applicable laws and regulations of the area and terms and conditions of the authorization. The holder must acquire all permits or licenses of State or local government, as applicable, necessary to provide the services described above, and, must operate in compliance with all applicable Federal, State, and local laws and regulations, including, without limitation, all applicable park area policies, procedures and regulations. All vehicles/vessels/aircraft are required to be registered and the operators are required to have the proper licenses to operate them commercially, as required by law or regulation.
- 3. Employee Conduct: The holder must ensure that its employees are hospitable and exercise courtesy and consideration in their relations with the public. The holder must establish appropriate screening, hiring, training, safety, employment, termination and other policies and procedures. The holder must review the conduct of any of its employees whose action or activities are considered by the holder or the Director to be inconsistent with the proper administration of the Area and enjoyment and protection of visitors and must take such actions as are necessary to correct the situation. The holder must maintain, to the greatest extent possible, a drug free work environment.
- **4. Rates:** The holder shall provide commercial services under this authorization to visitors at reasonable rates satisfactory to the area Superintendent.
- 5. Operating Conditions: The holder shall provide the authorized commercial services to visitors under operating conditions satisfactory to the area Superintendent.
- 6. Liabilities and Claims: This authorization is issued upon the express condition that the United States, its agents and employees shall be free from all liabilities and claims for damages and/or suits for or by reason of any injury, injuries, or death to any person or persons or property of any kind whatsoever, whether to the person or property of the holder, its agents or employees, or third parties, from any cause or causes whatsoever while in or upon said premises or any part thereof during the term of this authorization or occasioned by any occupancy or use of said premises or any activity carried on by the holder in connection herewith, and the holder hereby covenants and agrees to indemnify, defend, save and hold harmless the United States, its agents, and employees from all liabilities, charges, expenses and costs on account of or by reason of any such injuries, deaths, liabilities, claims, suits or losses however occurring or damages growing out of the same.
- 7. Insurance: Holder agrees to carry general liability insurance against claims occasioned by the action or omissions of the holder, its agents and employees in carrying out activities and operations under this authorization. The policy shall name the United States of America as additional insured. Holder agrees to have on file with the park copies of the above insurance with the proper endorsements.
- 8. CUA Fees: At a minimum, the holder shall reimburse the park for all costs incurred by the park as a result of accepting and processing the application and managing and monitoring the authorized activity. Administrative costs for the application process must be paid when the application is submitted. Monitoring fees and any additional costs incurred by the park to support the commercial activity will be paid annually or on a more frequent basis as determined by mutual agreement between the Holder and the area Superintendent.
- **9. Benefit:** No member of, or delegate to, Congress, or Resident Commissioner shall be admitted to any share or part of this authorization or to any benefit that may arise from this authorization. This restriction shall not be construed to extend to this Contract if made with a corporation or company for its general benefit.
- 10. Transfer: This authorization may not be transferred or assigned without the written consent of the area Superintendent.
- **11. Termination:** This authorization may be terminated upon breach of any of the conditions herein or at the discretion of the area Superintendent.
- **12. Preference or Exclusivity:** The holder is not entitled to any preference to renewal of this authorization except to the extent otherwise expressly provided by law. This authorization is not exclusive and is not a concession contract.
- **13. Construction:** The holder shall not construct any structures, fixtures or improvements in the park area. The holder shall not engage in any groundbreaking activities without the express, written approval of the area Superintendent.

14. Reporting: The holder must submit annually the CUA Annual Report (NPS Form 10-660) by January 31 for the prior CUA season and also must submit upon request the CUA Monthly Report (NPS Form 10-660A). The holder is to provide the area Superintendent upon request any other specific information related to the holder's operations that the area Superintendent may request, including but not limited to, visitor use statistics, and resource impact assessments.

- **15. Accounting:** The holder is to maintain an accounting system under which its accounts can be readily identified within its system of accounts classification. This accounting system must be capable of providing the information required by this authorization. The holder grants the United States of America access to its books and records at any time for the purpose of determining compliance with the terms and conditions of this authorization.
- **16. Minimum Wage:** The holder must comply with all provisions of Executive Order 14026 of April 27, 2021, (Increasing the Minimum Wage for Federal Contractors) and its implementing regulations, including the applicable contract clause, codified at 29 C.F.R. part 23, all of which are incorporated by reference into this authorization as if fully set forth in this authorization.
- 17. Visitor Acknowledgment of Risks (VAR): The holder is not permitted to require clients sign a waiver of liability statement or form, insurance disclaimer, and/or indemnification agreement waiving the client's right to hold the CUA holder responsible for accidents or injury occurring on NPS property. The holder is permitted to request or require a client to sign a form or statement acknowledging risk and/or indicating that certain prerequisite skills may be needed to participate in the commercial activity. The holder must provide the park with the current copy of all forms and/or statements used for this purpose and obtain written approval by the park to use the form and/or statement. A sample Acknowledgment of Risk form may be obtained by contacting the CUA office at 760-221-4740 or by going to the park CUA webpage at Permits & Reservations Mojave National Preserve (U.S. National Park Service) (nps.gov).
- 18. Intellectual Property of the National Park Service: Except with the written authorization of the Director of the National Park Service, the Holder shall not assert any legal claim that the Holder or any related entity holds a trademark, tradename, servicemark or other ownership interest in the words "National Park Service", the initials "NPS", or official name of any unit or part thereof, including but not limited to any facility, logo, distinctive natural, archaeological, cultural, or historic site, within the National Park System, or any colorable likeness thereof, or the likeness of a National Park Service official uniform, badge, logo, or insignia.
- **19. Nondiscrimination:** The holder must comply with Applicable Laws relating to nondiscrimination in providing visitor services to the public and with all equal employment opportunity provisions of Title VII of the Civil Rights Act, as amended.
- 20. Notification of Employee Rights: The holder must comply with all provisions of Executive Order 13496 of January 30, 2009, (Notification of Employee Rights Under Federal Labor Laws) and its implementing regulations, including the applicable contract clause, codified at 29 CFR part 471, appendix A to subpart A, all of which are incorporated by reference into this authorization as if fully set forth in this authorization.

## SPECIAL PARK CONDITIONS COMMERCIAL USE AUTHORIZATION

- 21. This permit holder will notify Mojave National Preserve at least 24 hours before each entry into Mojave National Preserve. EMAIL CONTACT: moja\_permits@nps.gov. TELEPHONE CONTACT: Matt Caire: 760-221-4740.
- **22.** The authorization holder must carry a copy of this authorization while conducting commercial services in Mojave National Preserve. This copy may be either hard copy (i.e., paper) or digital.
- 23. This authorization is applicable for the use of the area(s) and terms designated herein. Activities allowed under this authorization are restricted to existing roads and trails within Mojave National Preserve that are open to public access.
- 24. No employee of the National Park Service may conduct commercial services in Mojave National Preserve under this authorization. NPS employees may not work on matters involving a business in which they, their spouse, or their minor children have a financial authorization (NPS Management Policies 2006 10.2.8.3).
- 25. \_\_\_\_ and its contractor(s) must orient themselves with the biology of tortoises, threats to tortoises, and tortoise-protective measures before arriving at Mojave National Preserve. Brief videos are available on the Internet good examples include: Desert Tortoise 101 Everything You Need To Know YouTube and/or Video (U.S. National Park Service) (nps.gov).
- 26. The permitted activities might be conducted at a time when the desert tortoise is active above ground (typically March 1 October 31) or in areas that may disturb habitat. \_\_\_\_\_ or its contractor(s) must exercise care to prevent injury or death to tortoises and preserve their habitat. A threatened species and protected by state and federal laws, this reptile is susceptible to disturbance, vehicle strikes, human induced predation, and loss of habitat. Juvenile tortoises are especially vulnerable. Tortoises are active

throughout the day when temperatures are mild (mid 70sF - 90sF). They are often seen on or near paved road areas, particularly after rains. Participants in the activities approved in this authorization must be informed of and comply with the conditions in this authorization.

- 27. It is illegal to disturb a tortoise or its habitat. This includes handling, moving, or possessing a tortoise, and altering or destroying habitat.
- 28. Tortoises sometimes crawl under parked vehicles. Always check under vehicles, especially around the tires, before moving the vehicle if it has been parked longer than two minutes.
- 29. Motorized vehicles must remain on existing roads, designated routes, and vehicle ways. Vehicles will remain on established roads or parking areas. Vehicle operators must watch for tortoises on the road or road shoulder area. Vehicle operation off established roadways and parking outside designated parking areas are prohibited.
- **30.** Speed limits must be strictly followed to allow time to respond if a tortoise is seen on the roadway. Generally, Mojave National Preserve's speed limits are 55 MPH on paved roads, 35 MPH on most graded-maintained roads, and likely slower on two-track roads. Vehicle operators must look for posted speed limits on roadways.
- **31.** When vehicles travel in a group, each vehicle will be spaced far enough apart to ensure visibility of the road surface to avoid desert tortoises.
- **32.** Secure, carry out, and properly dispose of food scraps. Scraps attract predators of desert tortoises, which can lead to greater predation pressures.
- **33.** Permit-related tortoise injuries and/or deaths must be reported to Mojave National Preserve as soon as possible. Contact Matt Caire: matthew\_caire@nps.gov or 760-221-4740.
- 34. No motorized vehicles may be operated in wilderness areas. No motorized equipment or mechanized transport, including vehicles, may be operated in wilderness. In general, wilderness begins: 100 feet to either side of the centerline of maintained roads (e.g., Kelbaker Road, Cedar Canyon Road, Black Canyon Road, Ivanpah Road, Morning Star Mine Road, Kelso Dunes Road, etc.); or \*30 feet to either side of unmaintained roads.
- 35. Vehicles will use only existing roads or previously disturbed areas outside wilderness.
- 36. Wildlife, particularly animals with young and nesting birds, should not be harassed in any form.
- **37.** Parking shall take place only on previously disturbed sites.
- 38. Vehicle parking must occur more than 200 yards from natural and constructed water sources.
- **39.** Company drivers must follow speed limits and avoid objects on roads.
- **40.** Permittee will ensure that no damage to vegetation or wildlife occurs. Vegetation in the Preserve may not be cut, trimmed, or moved. No disturbance of soil or mineral matter is allowed, including pounding stakes into the soil. All disturbances will be reported to the National Park Service for possible restoration.
- 41. Collection of plants, animals, or mineral specimens is prohibited. Destruction of vegetation or natural areas is not permitted.
- **42.** No exotic plants or animals will be introduced into or left behind in Mojave National Preserve.
- 43. Permission for travel on or across private property must be obtained from the appropriate landowner.
- **44.** Activities under this authorization will be conducted in accordance with the California Desert Protection Act of 1994 and comply with all State and Federal laws.
- **45.** Collecting, defacing, or destroying historic or prehistoric artifacts is prohibited. Archeological historic structures and artifacts will be left undisturbed. Rubbings or other types of transfer of form of rock art is prohibited. Permittee will immediately bring to the attention of Mojave National Preserve any archeological resources encountered during commercial operations and maintain the integrity of such resources pending subsequent investigation. **46.** Discarding or spilling of any fuel or hazardous materials is prohibited. Any discharge or spill must be reported immediately. CONTACTS: (909) 356-3805, San Bernardino County Communications Center and 909-383-5651, Federal Interagency Communications Center. In case of emergency, call 9-1-1.

- **47.** Areas that are visited will be left as if no one had been there. Garbage, including food materials, must be carried out and disposed of in a proper manner. Human waste must be disposed of properly in public toilets available in the Preserve (e.g., Kelso Depot Visitor Center, Kelso Dunes trailhead). Cigarette butts are litter; permittee will provide butt cans for disposal. Permittee is responsible for removing all trash.
- **48.** Permittee will provide for basic first aid and initial transport at the standard first aid level. For other emergencies, Permittee will call 9-1-1.
- 49. No sales of promotional items or promotional filming of activities is authorized under this authorization.
- 50. Pets must be confined to or on a leash no longer than six feet in length.
- 51. and its clients must read Mojave National Preserve's Leave No Trace worksheet (attached).
- **52.** The Permittee agrees that the terms and conditions of the authorization will not establish a precedent for a future authorization at Mojave National Preserve or another unit of the National Park Service. Failure to follow the conditions of this authorization may result in revocation of this authorization and denial of future authorizations.
- 53. Other terms and conditions may apply.

### Commercial General Liability (CGL) Insurance

Liability insurance is required for all CUA holders under the terms of the authorization. Such insurance should be of sufficient scope to cover all potential risks and in an amount to cover claims that can reasonably be expected in the event of serious injury or death. The minimum commercial general liability insurance is \$500,000.00. Liability insurance policies must name the United States of America as additional insured. The business or person that is providing the service must be the named insured (policy holder). Companies that provide transportation only are not required to have Commercial General Liability as long as the passengers do not disembark.

#### Other Required Insurance

**Commercial Auto Liability Insurance** is required if a CUA holder transports passengers or uses in the performance of the service in the park owned/leased/rented vehicles. If a CUA holder charters the vehicle and those chartered vehicles are owned and operated by another company, the CUA holder is not required to have Commercial Automobile Liability insurance. The minimum Commercial Auto Liability Insurance for *interstate* passenger transport is:

15 or fewer passengers	\$1,500,000	
16 or more passengers	\$5,000,000	

The NPS has not established standard commercial automobile liability minimums for intrastate auto use by CUA holders because each state has unique rules and regulations. Intrastate CUA holders must meet individual state requirements for Commercial Automobile Liability Insurance or the interstate requirements above, whichever are greatest.

If the CUA applicant or holder will use rented or leased vehicles in performance of the authorized service, the applicant or holder must secure appropriate insurance for that rented or leased vehicle in the amount required by the CUA application. Proof of insurance secured directly from the rental or lease company may not be available upon application submission, but applicants are required to provide proof of insurance coverage after application submission upon NPS request.

#### **Insurance Company Minimum Standards**

The NPS has established the following minimum insurance **company** requirements. All insurance companies must meet the following minimum standards. These standards apply to foreign insurance companies as well as domestic companies.

- 1. All insurers for all coverages must be rated no lower than A- by the most recent edition of Best's Key Rating Guide (Property-Casualty edition), or similar insurance rating companies (Moody's, Standard and Poor's, or Fitch), unless otherwise authorized by the Service.
- All insurers for all coverages must have Best's Financial Size Category of at least VII according to the most recent edition of Best's Key Rating Guide (Property-Casualty edition), or similar insurance rating companies (Moody's, Standard and Poor's, or Fitch), unless otherwise authorized by the Service
- The insurance ratings must be submitted with the CUA Application. The rating companies do not issue certificates. We
  require the insurance broker to note this rating in the Certificate. If the rating does not appear on the certificate, the insurance
  broker must provide it in another document.

#### **Proof of Insurance Submission**

Applicants must submit proof of insurance with the CUA Application. The proof of insurance must:

Be written in English with monetary amounts reflected in USD.
Reflect that insurance coverage is effective at time of CUA Application submission.
Name as insured the business or person that is providing the service.
Name the United States as additional insured.
Reflect a General Commercial Liability Policy with the minimum coverage amount required in the CUA Application.
Reflect required additional insurances (commercial vehicle, vessel, aircraft, etc.) with the minimum coverage amount required
in the CUA Application.
Include insurance provider rating or provide in separate document.
