


Grassland and flats

Padre Island National Seashore

- Established 1962
- 65 miles of beach (longest undeveloped barrier island beach in U.S.)
- Year-round public beach driving on all but 4 ½ miles
- 150 sensitive (at-risk) species including 5 sea turtle spp.
- 5 ESA-listed sea turtles
 - Kemp's ridley
 - Green
 - Hawksbill
 - Leatherback
 - Loggerhead

Changes Following the 2020 Program Review

- Implemented Incident Command System for public events
 - This <u>has</u> reduced the number of public hatchling releases.
 - This <u>has not</u> reduced number of sea turtle hatchlings that are released by the park. Hatchlings continue to increase.
- Better distributed workload, including hiring seasonals and limiting overtime, to reduce risk of burnout and injury
 - This has reduced costs associated with overtime (was ~15% of base).
 - This <u>has not</u> impacted program mission or outcome. More seasonals hired.
- Realigned the sea turtle education program to the Interpretation + Education Division
 - This <u>has not</u> impacted availability of public education programming.
- Clarified process for media and social media engagement
 - This <u>has</u> established appropriate channels to vet media requests.
 - This <u>has not</u> prohibited staff from speaking to the media.



Next Steps for the Program

- PAIS is dedicated to supporting listed species recovery and the financial sustainability of the program.
- Strategic and operational planning is needed to design a sustainable program.
 - Includes identifying staffing needs, budget resources, FWS consultation, and NEPA planning.
 - Align NPS actions with its commitments in species recovery plans.
- The turtle program will be relocated under the park's Resource Management Division.
 - Will ensure resources can be maximized by sharing positions, leveraging partnerships, and integrating new technology.
