Application Process:

- A \$25 non-refundable application fee is required with application.
- April 18 November 7, 2025: Applications accepted October 1- December 1, 2024. Notification of reservations will be made by January 1, 2025.*
- November 8, 2025- April 12, 2026: Available at Cabin Camp 5 only. Applications will be accepted after February 1, 2025 on a first come, first serve basis.
- There is a 2 night minimum rental on weekends.

*Applications will also be accepted throughout the season once initial applications have been processed and groups have been placed.
