Pursuant to Public Law 113-291, I am pleased to transmit the Lackawanna Valley National Heritage Area Evaluation Findings (Evaluation). The National Park Service (NPS) engaged Westat as the evaluator to independently assess the progress, analyze the investments, and identify the critical components for sustainability of the national heritage area. Based on the findings of the Evaluation, the NPS recommends a future role with the Lackawanna Valley National Heritage Area (LVNHA). The NPS will work with the LVNHA to implement business, fundraising, and financial resource development plans and continue to form networks of operational and financial partnerships to further long-term sustainability of the LVNHA operations.

In 2000, Congress designated the LVNHA along the Lackawanna River watershed, including Lackawanna County, and parts of Luzerne, Susquehanna, and Wayne Counties. The legislation noted anthracite coal mining, iron-making, textiles, rail transportation industries, as well as the development of labor unions as nationally significant. The Lackawanna Heritage Valley Authority (LHVA), a municipal authority in Scranton, Pennsylvania, is the coordinating entity and also manages the state heritage area designated in 1991. In 2008, Heritage Valley Partners was formed as a non-profit fundraising arm to improve sustainability.

The Evaluation determined that the LHVA addressed the legislated purposes and goals outlined in the management plan with the support of the federal resources provided. The LHVA successfully met the 50 percent federal funding match requirements from 2000 to 2014, with a total of over \$12.8 million in nonfederal funds matched to \$7.1 million in NPS Heritage Partnership Program dollars. Funds from the State, the County, and other partners were used as matching funds. The LHVA received \$3.9 million in other Federal funds, mostly from the Federal Highway Administration. From 2000-2014, a total of \$30.1 million in financial resources were directed toward LVNHA activities.

The Evaluation concludes that the LHVA was fiscally responsible in expending funds. The largest investments by the LHVA were in parks and restoration (72 percent of funding), including the Lackawanna River Heritage Trail (LRHT) and the Lackawanna Heritage Valley Riverfront Greenway.
