## HISTORY

For most of Yellowstone National Park's (YELL) early history it was US Army and park policy to exterminate the gray wolf (*Canis lupis*), also known as northern rocky mountain gray wolf (*Canis lupis irremotus*) within park boundaries. Wolf populations in the American West were already declining due to fur trappers and ranchers. This led to a significant decrease in wolves in YELL through the 1920s to the 1960s, with only a dozen or so reported sightings each decade.

Gray wolves were placed on the Endangered Species List (ESL) after the passage of the Endangered Species Act (ESA) in 1973, leading to the establishment of the Northern Rocky Mountain Wolf Recovery Committee by the National Park Service (NPS) and US Fish and Wildlife Service (FWS). Led by the Montana Department of Fish and Game, committee members were tasked with completing the *Northern Rocky Mountain Wolf Recovery Plan* and *Wolves for Yellowstone? A Report to the US Congress*. The recovery plan identified three recovery areas where wolf recolonization was likely to occur with or without intervention and set the standard for delisting in Montana, Idaho, and Wyoming. Two recovery areas were thought to likely recolonize naturally, as gray wolves were already beginning to repopulate northwestern Montana. The third recovery area, which encompassed YELL, was identified and proposed as a wolf translocation site. The second report investigated the potential effect of wolf recovery in the park. The NPS also hired biologist John Weaver to complete a survey of the wolf population in the park, of which he found little evidence.

Despite the popularity of gray wolves in the public imagination and the letters of support for reintroduction arriving in YELL as early as the 1970s, wolf reintroduction was hotly contested. Organizations such as the Wyoming Woolgrowers Association and the Wyoming chapter of the American Farm Bureau were opposed to wolf reintroduction due to the risk of livestock depredation. Gray wolves' presence on the ESL made killing them a federal crime, even ones who repeatedly depredated. This was also source of confusion for federal and state employees who were expected to both protect endangered species and citizens' property. In 1982, Congress amended the ESA to include the "experimental population" provision, which provided exceptions to different requirements in the ESA for designated areas.

The Wolf Management Committee, established by the US Congress in 1990, also recommended a wolf reintroduction program in YELL to Congress with the recovery areas designated under the "experimental population" provision specified in the amended ESA, but their recommendation was again not acted upon.

In 1992 Congress asked the FWS, Forest Service, and NPS to complete an Environmental Impact Statement (EIS) on wolf reintroduction by 1994. The Draft EIS (DEIS) addressed concerns presented in public hearings and analyzed how various wolf recovery methods (including no intervention) would affect the recovery area in Idaho, Montana, and Wyoming. After the Department of Interior selected a preferred method for reintroduction the DEIS was released for public comment. During the DEIS's comment period, over 160,000 public comments were received. The Final EIS was edited following the review of these comments, released, and signed by Secretaries Bruce Babbitt and Mike Espy in May 1994.

Yellowstone's preparations for the release were already underway by 1994. Modeled after the red wolf "soft reintroduction" method, pens were constructed in three separate and confidential sites in the northern part of the park. The wolves would stay in their pens for 6 weeks to acclimate to Yellowstone in the hopes that they would stay in the park. That winter, the wolves were dart-gunned and captured in Alberta, Canada, packed into crates, and flown out to the recovery areas.

On January 12th, 1995, news crews, members of the public, and NPS personnel, watched the wolf convoy pass through the Roosevelt Arch and into Yellowstone Park. Celebrations and plans were briefly hampered when the Wyoming Farm Bureau filed a lawsuit against the Department of Interior Secretary Bruce Babbitt to prevent the release. The wolves were kept in their cages and pens for several hours before an emergency injunction was filed and eventually the case was dismissed. The wolves were released from their pens and into Yellowstone during the last two weeks of March.

Several notable people have been associated with Yellowstone's Wolf Program and the 1995 reintroduction, including author and biologist Rick McIntyre, famed wolf biologist L. David Mech, NPS biologist John Varley, NPS biologist Doug Smith, author and conservationist Hank Fischer, Wayne Brewster of the NPS, Ed Bangs of U.S. Fish and Wildlife, wolf biologist and former project leader Mike Phillips, and Renee Askins, activist and founder of The Wolf Fund.

The Wolf Program, led by Mike Phillips from 1994 to 1997, has been a part of the Yellowstone Center for Resources (YCR) since the YCR was started in 1993 under the direction of Dr. John Varley. To this day, the Wolf Program continues to monitor wolf packs in Yellowstone, through den studies, radio collaring, quantifying predation and wolf mortalities, and observing the reintroduction has had on the landscape and prey population of Yellowstone. Biologist Doug Smith lead the Wolf Program from 1998-2023, before handing the project over to biologist Dan Stahler. In 2003, gray wolf populations in Montana, Idaho, and Wyoming met the qualifications for delisting from the endangered species list but were only officially removed in 2011 and 2012. The gray wolf was briefly relisted in Wyoming in 2014 and delisted again in 2017.

**Timeline:**

- 1880: Superintendent Norris claims in his Annual Report that wolves have been nearly hunted to extinction in Yellowstone due to their valuable coats.
- 1886: US Army arrive at Yellowstone, less poaching happens overall but the emphasis is on game protection.
- 1885: The US Biological Survey is created by the Congress, a precursor to the US Fish and Wildlife agency.
- 1912: Wolf population noticeably rises in the northern part of the park.
- 1914-1926: Wolf population is significantly curtailed during a concerted and deliberate extermination campaign in the northeast section of the park by the outgoing Army administration (with instruction by the US Biological Survey chief naturalist Vernon Bailey) and incoming National Park Service personnel.
- 1916: NPS is established and takes control of Yellowstone in 1918, one of their first assignments is predator control.
- 1923: The last known den in Yellowstone is destroyed.
- 1935: Predator control policy is ceased in national parks.
- 1968: Park establishes new system for formally documenting wolf sightings, which is thought to have led to an increase of sightings.
- 1971: First interagency meeting for Northern Rocky Mountain Wolf management is held.
- 1973: The Endangered Species Act (ESA) is passed. The gray wolf is placed on the Endangered Species List (ESL).
- 1974: Interdisciplinary Northern Rocky Mountain Wolf Recovery Team (NRMWRT) led by Montana Fish and Game department representative Dennis Flath is formed and considers reintroduction.
- 1975: Biologist John Weaver is hired by the NPS to research the status of gray wolves in Yellowstone, publishes his survey results in 1978.
- 1980: The “Northern Rocky Mountain Wolf Recovery Plan” is completed, revised, publicly commented on, and approved by the FWS in 1987.
- 1982: Congress amends the ESA to include the provision for ‘experimental population’ which gives government agencies more freedom in developing reintroduction programs.

- 1987: NPS establishes wolf information program. 100th Congress 1st Session, H.R. 3378 “To require the National Park Service to reintroduce wolves into Yellowstone National Park” bill is introduced by Congressman Wayne Owens, but never passes.
  - 1988: NPS and FWS are instructed by Congress to conduct the Wolves for Yellowstone? Report, Vol. I and IIs is finished in 1990 and Vol. III and IV in 1992. Interim Wolf Control Plan is approved.
  - 1990: Wolf Management Committee (WMC) and Wolf Management Technical Committee (WMTC) is established by Congress with Galen Buterbaugh of the FWS and Wayne Brewster of the NPS as chairmen respectively. The WMC recommends relocation of wolves to YELL as an experimental population in 1991 but is not acted upon by Congress.
  - 1992: FWS, Forest Service, and NPS are instructed by Congress to prepare an EIS on wolf recovery.
  - 1993: Draft EIS is completed and submitted for public review, receiving over 160,000 public comments.
  - 1994: Final EIS is released and signed by Secretaries Bruce Babbitt and Mike Espy.
  - 1995: First fourteen wolves arrive in Yellowstone and following the denied injunction by the Wyoming Farm Bureau are released into their pens.
  - 1997: Budget cuts in Congress prevent future translocation efforts of wolves as planned.
  - 2000: The Denver, Colorado 10th Circuit upholds the legality of wolf reintroduction in the park when trying Wyoming Farm Bureau’s appeal.
  - 2003: Minimum levels of wolves in Montana, Wyoming, and Idaho to meet delisting criteria are met, but are not delisted until 2011-2012. Wolves are relisted in 2014 and delisted again in 2017.

## **SCOPE AND CONTENT**

### **YELLOWSTONE NATIONAL PARK WOLF PROGRAM RECORDS 1920-2012, bulk 1974-2012**

#### **DESCRIPTION**

This collection contains records related to the development of the reintroduction program of gray wolves in Yellowstone National Park, including early data collected on the reintroduced wolves. These records are the product of the development and implementation of the Wolf Program including: inter- and intra- agency correspondence regarding gray wolves, information requests and letters from the public, committee and conference meetings, the Northern Rocky Mountain Wolf Recovery Team, the Wolf Management Committee, the wolf reintroduction Environmental Impact Statement (EIS), and slides, photographs, and data collected from the reintroduced wolf population in Yellowstone.

This collection is particularly strong in EIS and wolf reintroduction implementation records, documentary footage and news coverage of the reintroduction, and wolf behavior and sighting data. Topics include administrative project records (reports, briefing statements, project outlines, schedules, cost estimates, correspondence, notes, and memos), the Northern Rocky Mountain Wolf Recovery Team and plan, Wolf Management Committee records, the wolf reintroduction Environmental Impact Statement, public comments, public opinion and correspondence with DOI or Yellowstone personnel on gray wolves, issue scoping records, wolf research and publications, reintroduction implementation correspondence, litigation, wolf reintroduction data (kills, pens, processing, observation, tracking, activity log), the Wolfstock program, Yellowstone wolf packs (e.g. Rose Creek, Druid) data, news reports and press releases, footage of wolves in the park, and non-profit wolf recovery groups records. Materials include correspondence, meeting minutes and agendas, memos, notes, draft and final recovery plans, recommendations and reports to the US Congress, newspaper clippings, research articles, maps, monitoring and observation data, legal materials, incident command documentation (Wolfstock), floppy discs (three-inch and five-inch), 35 mm photographic slides, photographs, and audiovisual material including Hi-8 tapes, CDs/DVDs, MiniDV tapes, and VHS tapes of wolf and news footage.

The Wolf Reintroduction Planning series contains materials such as reference articles and information on gray wolves and wolf reintroduction, Northern Rocky Mountain Wolf Recovery Team documentation, and the *Wolves for Yellowstone?* report. The Wolf Management Committee series consists mostly of meeting notes, correspondence, agendas and minutes from the Wolf Management Committee and Wolf Management Technical Committee. The Environmental Impact Study series includes reference materials supposedly used to support wolf reintroduction EIS, DEIS, EIS, and FEIS planning and working notes, and public comments and hearings documentation. The Wolf

Program Implementation series consists of materials related to Operation: Wolfstock, bulletins and the Wolf Tracker newsletter, release day planning, pen security planning, and photographs of field wolf research in the late 1990s. The Litigation series includes court documents related to the Downes ruling and Wyoming Farm Bureau v. Babbitt case, the United States v. Chad McKittrick, and a delisting lawsuit. The Public Information & Correspondence series contains materials related to public information campaigns and correspondence with the public regarding wolves, news footage, and video footage from DMW productions and Busch Productions Inc., The Observations, Surveys, and Data series is comprised of observation and monitoring data, slides, research reports and results, and wolf sighting forms.

This collection has research potential for wolf, ungulate, and wildlife biologists, wildlife management researchers, and those interested in the development and implementation of the wolf reintroduction program in Yellowstone or re-wilding programs in the United States generally. Due to the wolf program's impact and high profile, interpretation and public information programmers may also be interested in this collection. In that same vein, historians or researchers with an interest in public attitudes towards wolves or the controversy of the program may also use this collection.

### **ORGANIZATION**

Organized into seven series: Series I: Wolf Reintroduction Planning Records; Series II: Wolf Management Committee Records; Series III: Environmental Impact Study (EIS) Records; Series IV: Wolf Program Implementation Records; Series V: Litigation Records; Series VI: Public Information & Correspondence Records; Series VII: Observations, Surveys, and Data Records.

The materials in Series I through Series IV and Series VII are arranged alphabetically on subject matter, creator, or function then chronologically. Series V is organized chronologically then alphabetically to keep similar court cases together.

Some containers in Series II, Series III, Series IV, Series VI, and Series VII have been separated into cool storage for size and format considerations and are replaced with an "out" card in the archives collection space. The separated Series VI boxes are almost entirely VHS tapes, Betacam tapes, film negatives, and film reels.

**PROVENANCE** Transferred to the archives from the Wolf Program Office in the Yellowstone Center for Resources division in 2012, 2021-2022, and 2024.

**RESTRICTIONS** Yes: Most tapes in Series VI: Public Information & Correspondence are still copyrighted and may not be distributed or duplicated without creator permission or if the tapes are properly transferred to the NPS. Consult the archivist for more information.

## ***SERIES DESCRIPTIONS***

### ***I. Wolf Reintroduction Planning Records, 1970s-1997***

The Wolf Reintroduction Planning Records series contains materials relating to wolves and wolf recovery mostly prior to reintroduction in the park. Formats include: newspaper clippings, reports, correspondence, memos, meeting minutes, transcripts, plans, maps, legislative materials, and research proposals. This series also contains photographs and floppy disks.

One major topic in this series is the Northern Rocky Mountain Wolf Recovery Team (NRMWRT), which was formed by law after the passage of the ESA and gray wolves were listed. The NRMWRT was led by Montana Fish and Game but included NPS and FWS officials as well. Another major theme of this series is wolf recovery efforts and interest in the park prior to reintroduction. Materials related to this theme include project proposals and reports on public opinion on wolves in Montana, Idaho, and Wyoming. Another major topic is *Wolves for Yellowstone? A Report to US Congress*. Completed through 1991 to 1992, *Wolves for Yellowstone?* was the last in a series of reports leading up to the EIS that assessed the impact of wolf reintroduction in Yellowstone. Records of the development of the report including volumes 1 through 3 are in this series while more data-driven portions of the report are in the Observations, Surveys, and Data series. Other topics present include: reference material on wolf reintroduction, correspondence with conservation groups, the *Northern Rocky Mountain Wolf Recovery Plan*, gray wolf reclassification and taxonomy, Greater Yellowstone Area Wolf Coordination Committee records, public hearings on wolf reintroduction, the North American Symposium on Wolves, gray wolf research articles and research, wolf management, congressional hearings and reports on wolf reintroduction, and correspondence with Congressman Wayne Owens of Utah, Wyoming Senators Alan Simpson and Malcolm Wallop, and Secretary of Interior Donald Hodel.

While there is some reference material in this series the reference material used during the EIS process is in the Environmental Impact Study series. Records of the public expressing interest in wolf reintroduction or requesting information prior to reintroduction are in the Public Information & Correspondence series.

Records are arranged first alphabetically by creator (e.g. Bath, Alistair, Northern Rocky Mountain Wolf Recovery Team), project (e.g. *Wolves for Yellowstone?* report), or subject (e.g. Wolf Management Planning) when applicable, then format, and finally chronologically.

### ***II. Wolf Management Committee Records, 1972-1992***

The Wolf Management Committee Records series contains administrative and derivative documentation from the Wolf Management Committee (WMC) and Wolf Management Technical Committee (WPMC). Formats include: memos, reports, correspondence, briefing notebooks, meeting minutes, press releases, articles, schedules, and data. This series also contains Super 8 film, floppy disks, and 35mm slides.

A major topic in this series is the recommendation the WMC would eventually make to the US Congress in 1991, including correspondence, meeting minutes between WMC members, and planning alternatives for wolf reintroduction in the park. The WMC and WPMC were related but separate committees, the WPMC consisting of people appointed by members of the WMC to perform research,

attend meetings, and vote on issues in their stead. More planning information for the Wolf Program prior to the EIS is also in the Wolf Reintroduction Planning Records series.

Records are arranged first alphabetically by creator, either the WMC or the WMTC, and topic or form, then chronologically.

### *III. Environmental Impact Study (EIS) Records, 1969-1997*

The Environmental Impact Study (EIS) Records series contains administrative and derivative documentation of the EIS done to explore the impacts and potential methods of wolf recovery in Yellowstone. Formats include: reference articles and materials, newspaper articles, correspondence, public and agency comments, transcripts, brochures, analyses, meeting agendas and minutes, reports, and notes. This series also contains VHS tapes and floppy disks.

This series includes the Draft EIS (DEIS), the EIS, and the Final EIS (FEIS), the DEIS and FEIS being two different if related documents. A major topic in this series is the reference material used to draft and complete the EIS. Depredation of livestock was a common issue anti-wolf reintroduction individuals and organizations had, which is reflected in the number of public comments and hearings in this series. Other major topics include: issue scoping, public hearings, livestock and livestock depredation, EIS drafts, alternative scoping, EIS meeting minutes and correspondence between FWS, NPS, and other officials, regular reports on the EIS process, EIS planning notes and materials, and gray wolf research literature. Public opinion on wolf reintroduction generally is in the Public Information & Correspondence Records series.

Records in this series are arranged first alphabetically by project, subject, creator, or purpose (e.g. minutes, memos, and correspondence) and then chronologically.

### *IV. Wolf Program Implementation Records, 1983-2007*

The Wolf Program Implementation Records series includes planning for wolf reintroduction after the EIS and documentation of early Wolf Program activities. Formats include: reports, project planning, administrative histories, correspondence, plans, memos, research proposals, log notes, applications, briefing statements, memos, news releases, news articles, and incident command system assignment lists.

A major topic of this series is “Wolfstock,” the name given to the project where gray wolves would be released into Yellowstone for the first time. Wolfstock assignments for logistics, operations, and planning among other responsibilities were presented under an incident command system structure. Another major topic in this series are the wolves themselves and the Wolf Program’s interactions with them including collaring or documenting dens. There are also many different kinds of reports in this series, including activity, annual, and agency-specific reports. Other topics include: photographs of wolves in or destined for Yellowstone, acclimation pen construction, arrival event planning and schedules, project funding, wolf reintroduction updates, security, pen site selection and monitoring, FWS weekly reports, wolf recovery updates. More specific observational and survey data regarding wolf reintroduction is available in the Observations, Surveys, and Data Records series.

Materials are arranged alphabetically by subject (e.g. #004M), topic (e.g. collaring), or format (e.g. activity reports, correspondence) then chronologically.

V. *Litigation Records, 1983-2008*

The Litigation Records series contains documents related to Yellowstone wolf reintroduction legal disputes, particularly directly after the first release. Formats include correspondence and legal forms. Legal forms present in the series include complaints, motions to intervene, motion for preliminary injunctions, witness declarations, orders, notices, summaries of findings, final decisions and rulings. Cases relevant to this collection include *Defenders of Wildlife v. Maunal Lujan Jr.*, *Wyoming Farm Bureau Federation v. Bruce Babbitt*, and *the United States v. Chad McKittrick*. The Wyoming Farm Bureau Federation case in particular is a major topic in this series, from the Downes' Agreement to the later appeal in the 10th Judicial District of Colorado. Other topics include: claims of ESA violations from conservation groups such as the Defenders of Wildlife and the Sierra Club against the Department of the Interior, the Downes' ruling in *Wyoming Farm Bureau Federation V. Bruce Babbitt*, a damages claim, Chad McKittrick's slaying of wolf #10, and a delisting lawsuit.

This series was sorted chronologically, then alphabetically to keep records relating to the same or concurrent cases together.

VI. *Public Information & Correspondence Records, 1972-2012*

The Public Information & Correspondence Records series includes materials related to public perceptions and reactions to the wolf reintroduction program as well as promotional or documentary materials of the wolves. Formats include: interviews, topical and documentary footage (audio and video), public affairs promotional videos, television news segments, correspondence, radio news segments, public information campaign materials, news and press releases, magazine and news articles, editorials, conference footage, public presentations, and exhibit planning.

A major creator in this series is DMW Productions Inc., which filmed the footage for a project titled "Wolves" in the early winter and summer of 1996. DMW Productions Inc. collaborated with the Busch Productions, also known as the Peter W. Busch Family Foundation in creating a documentary film titled "The Survival of the Yellowstone Wolves." Busch Productions was contracted by the FWS and NPS to capture footage of the Yellowstone wolf recovery project in 1995 and eventually produce a documentary, possibly "The Survival of the Yellowstone Wolves." The original 16mm camera negatives of the film are present in this collection as well as the work-prints of the later documentary. All original negatives have been digitized and the work-print film reels partially digitized for their continued preservation.

A major topic in this series is news coverage, both audiovisual and in print, regarding the wolf reintroduction in Yellowstone, public opinion on wolf reintroduction and wolves, and gray wolves specifically. Wolf reintroduction in Yellowstone and the controversy it generated was of interest nationally and even internationally, but especially in the western United States. Many varied perspectives of the wolf program are represented in this series, from individuals and organizations of different backgrounds and concerns throughout the planning of wolf reintroduction in the park, especially in the early 1990s. In the same vein, public correspondence to the park expressing support or disapproval for wolf reintroduction in Yellowstone from the 1970s to 2000 is also well represented.

The intellectual property rights of much of the footage in this series are not owned by the NPS. Please contact the Park Archivist for more information.

This series is arranged first alphabetically by topic or name of creator, and then chronologically or ascending numbers (e.g. "DMW Productions Inc., 'BK96H04' Betacam Tape, August 19, 1996" followed by "DMW Productions Inc., 'BK96H11' Betacam Tape, September 17, 1996").

## VII. *Observations, Surveys, and Data Records, 1920-2011*

The Observations, Surveys, and Data Records series includes documentation of activities and outputs of the Wolf Program's research into the wolves reintroduced into the park. Formats include: video footage, data, database files, research notes, research articles, sighting forms, presentations, observation notes, documentation of wolf packs, lone wolves, project results, and reports.

A major topic in this series is data gathered early on in the Wolf Program. This includes data about: acclimation duration, pack composition, pup births, mortalities, translocation, carcass and carcass surveys, den monitoring, behavioral observations (on specific packs), den disturbances, thirty-minute check-ins, observation, road management, tracking, and scat. Other research includes kill logs, observation notes, rare animal and wolf sighting forms going back to the 1920s, and slide transparencies of wolf packs, dens, deceased wolves, kills, kill sites, the acclimation pens, wolf processing and collaring, wolf captures, Wolf Program staff, and visitors.

The materials are arranged alphabetically by category (e.g. data, rare animal forms), creator (e.g. McIntyre, Rick) or topic (e.g. "Daley Creek Wolf Pup Capture") if applicable, and then chronologically.
